is particularly true for children deprived of liberty, who often remain invisible and forgotten. United Nations General Assembly (UNGA) Resolution 69/157 of 18

December 2014 requested the Secretary-General to commission an in-depth Global

study on children deprived of liberty. In October 2016, Manfred Nowak (Austria) was

appointed by the United Nations Inter-agency Task Force as Independent UN Expert

leading the Global Study on Children Deprived of Liberty.

We are the international coordination team of the Independent Expert, Manfred
